Description of Work : 2D Seismic Data Acquisition, Processing and Reprocessing

REPDMCC has plans to acquire 2D onshore seismic data of approximately 650 LKM in Rovi & Sarta blocks in Kurdistan. This survey has to be conducted using Explosive and Vibroseis as source. The tentative time of conducting the acquisition survey will be March 2011 and completed during July 2011. It should have the onsite field processing facility to generate daily field stack for day to day QC of the 2D seismic data.

REPDMCC has to carry out processing of about 650LKM of newly acquired 2D seismic data. In addition, reprocessing of 506LKM of old vintage data (acquired in 2008) is also proposed to be carried out. The processing objectives shall be to minimize the misties in the current and vintage data and to have the focus in data enhancement in the deeper zone.

Capability Requirement :

- Previous Experience of data acquisition in Kurdistan
- Minimum 10years of international experience of data acquisition
- Availability of the state of art equipment (not older than 1year)
- Should have the experienced man power for data acquisition and quality control for not less than 10years for key personnel
- Availability of onsite field processing unit for day to day QC using field stack
- Availability of state of art drilling unit to drill holes with variable depth ranging from 5m to 70m
- Availability of state of art recording unit of 24-bit wire line telemetry
