Shares under Category "Public" also include (i) 2 51 918 partly paid-up equity shares on which First Call as well as Second and Final Call has not been paid and accordingly, voting rights in respect of these shares can only be exercised upon payment of Second and Final Call. The fully paid-up equity shares for which corporate action was not completed as on June 30, 2024 including 965 equity shares for which call money has been received by the Company during the quarter ended June 30, 2024.

The shareholding percentage of Promoter & Promoter Group as shown in (VIII) (A) has changed (as compared to the shareholding percentage as on March 31, 2024) because (i) 22 39 324 equity shares have been deposited with ICICI Bank Limited, domestic custodian for The Bank of New York Mellon (GDR Depository) for issue of DRs and the shares underlying DRs have gone up as on June 30, 2024 vis-a-vis as on March 31, 2024 and (ii) allotment of 1 20 000 equity shares pursuant to Reliance Industries Limited Employees' Stock Option Scheme 2017.
